The role of fixed income in asset allocation

This panel will explore the evolving role of fixed income within modern asset allocation strategies. Given the current market dynamics and economic conditions, fixed income investments are increasingly being viewed not just for their income-generating capabilities, but also as a vital component of portfolio diversification and risk management. Experts will discuss how fixed income can be effectively integrated into diversified portfolios, especially in an era of changing interest rates and inflationary pressures.

The panel will also examine the challenges and opportunities that come with fixed income investments in today's environment, such as the impact of central bank policies, credit risks, and the growing importance of sustainable investing. Key questions will be raised regarding how best to balance fixed income assets alongside equities and alternative investments, and how these strategies can evolve to meet the needs of institutional investors and large asset owners.
