Sustainable UBS ETFs - What you need to know

MSCI Socially Responsible Investing Indices

The MSCI Socially Responsible Investing (MSCI SRI) indices are built upon three-pillars: Environmental, Social and Governance (ESG). Based on these pillars, the SRI index selects companies using a three-step approach:

- Business Involvement Screening Research Exclusion
 Negatively screens companies with a detrimental social or
 environmental impact including controversial weapons (zero
 tolerance), civilian firearms, nuclear weapons and tobacco
 (minimal tolerance), alcohol, gambling, nuclear power,
 conventional weapons, adult entertainment and genetically
 modified organisms (low tolerance) as well as thermal coal (not
 classified under any specific tolerance level). 1
- ESG Intangible Value Assessment (IVA) Rating
 Positively screens companies vis-à-vis sector peers by assigning
 each an ESG rating from AAA to CCC, based on ESG business
 practices (Figure 1). Only the highest ESG-rated companies are
 eligible for the SRI index.
- 3. ESG Controversies Scoring

Identifies companies that are involved in controversial activities, assessing how well companies adhere to international norms and principles such as UN Global Compact and ILO Core Conventions. MSCI ESG Controversies look at five different areas: Environment, Governance, Customers, Human Rights & Community and Labor Rights & Supply Chain.

In the MSCI SRI indices, stocks are market capitalization weighted and aim to provide similar performance as standard MSCI indices. The SRI indices aim to select companies with the strongest ESG profiles that cover about 25% of the market capitalization in each industry and region of the parent index.

UBS Socially Responsible Equity ETFs include companies with MSCI ESG (IVA) rating of 'A' or higher² and MSCI ESG Controversy score of 4 or higher.

UBS Sustainable Fixed Income ETFs include fixed-rate, investment grade, USD and EUR denominated securities, issued by US and Eurozone corporates with an MSCI ESG rating of 'BBB' or higher and MSCI ESG Controversy score of 2 or higher.

MSCI ESG Universal Indices

The MSCI ESG Universal index is designed to integrate ESG signals and retain diversified market exposure. But unlike the MSCI SRI framework, MSCI ESG Universal Index tilts away from market cap weights and seeks to enhance exposure to those companies that demonstrate both a higher MSCI ESG Rating and a positive ESG Trend. Based on the ESG criteria, the ESG Universal index filters companies using a three-step approach:

- 1. Exclusion of companies involved in controversial weapons and violations of international norms.
- Ranking of companies based on the sector-relevant ESG Rating and ESG Trend.
- 3. Re-weighting of the market cap weights based upon ESG rating and its trend. The reweighting is designed to reward consistent ESG performers, but also to favor companies with strong ESG momentum (incentive to improve).

Whereas MSCI SRI indices exclude and hence divest poor ESG performers, the MSCI ESG Universal Index simply associates lower weights to poor ESG performers, whilst maintaining a very broad universe.

- MSCI ESG Research has developed a framework designed to define significant involvement in controversial activities. According to this framework, there are three tolerance levels: Zero Tolerance, Minimal Tolerance and Low Tolerance. Companies being active as producers or distributors are either excluded based on any activity in one of these business areas or depending on a certain threshold of revenue; in relative (e.g. 5% or 15%).
- MSCI UK and Switzerland IMI Extended SRI: The IVA rating threshold was lowered to a minimum rating of "BBB" and Controversy Score of "1" at the initial construction.
